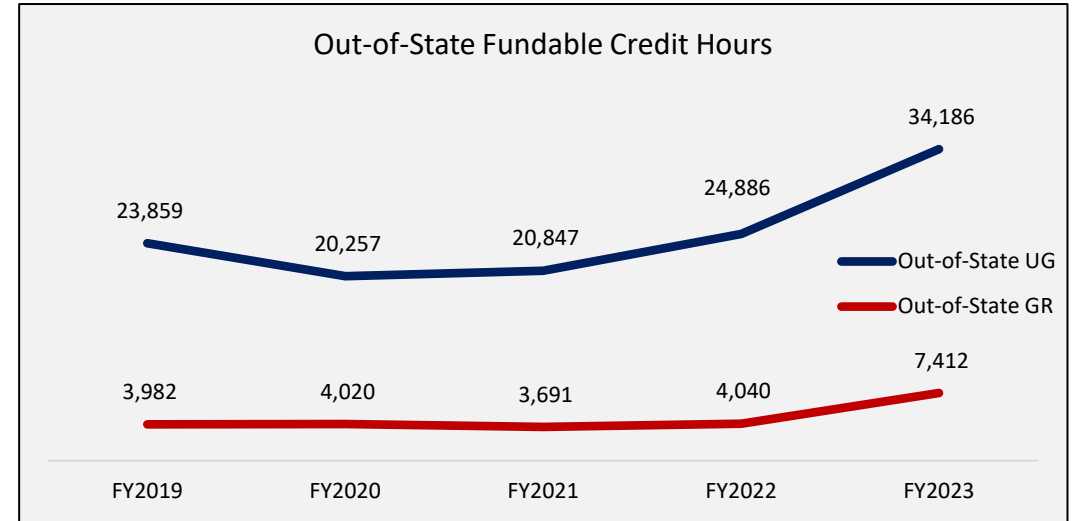

To forecast the remaining revenue & credit hours for FY23, we used the same actuals as reported for the first part of summer for FY22.

Tuition & waiver data for FY23 (Jul.1-Jan.31) was pulled 2/01/2023.

Out-of-State graduate tuition is down in FY23 partly due to the new \$0 out-of-state fee for GTA's. This will also cause waivers to be lower in FY23.

Tuition revenues exclude College of Medicine and market rate programs.
