# SUBJECT: APPROVE NAMING OF UNIVERSITY ELEMENTS

# **PROPOSED COMMITTEE ACTION**

Recommend that the BOT approves naming of the Athletic Center (Gymnasium) main entrance lobby within the proposed AD Henderson University School/FAU High School Complex (the "ADHUS/FAU High School Complex"). The proposed name of the lobby will be the "Rosemurgy Family Athletic Hall."

## **BACKGROUND INFORMATON**

#### **Donation**:

The Alexander S. Rosemurgy, II Revocable Trust is donating One Hundred Thousand Dollars (\$100,000) for a recognition opportunity to name the Athletic Center (Gymnasium) main entrance lobby within the ADHUS/FAU High School Complex.

#### Gift Purpose:

The gift will be used to assist with the planning, financing, constructing and equipping of the ADHUS/FAU High School Complex. The new facility is critical in facilitating student led research and engineering as AD Henderson University School/FAU High School provides opportunities for experiences beyond the classroom. This new facility will equip our faculty and students to impact the future for years to come.
