SUBJECT: APPROVAL OF THE FLORIDA ATLANTIC UNIVERSITY 2015-16 CAPITAL IMPROVEMENT PLAN

PROPOSED BOARD ACTION

Provide approval of the Florida Atlantic University 2015-16 Capital Improvement Plan (CIP-2) and Back-of-the-Bill (BOB) Legislative approval action forms.

BACKGROUND INFORMATION

The State University System (SUS) requires that each college and university update its CIP. The CIP is intended to present the additional academic and academic support projects needed for a five-year period. Additionally, Board of Governors (BOG) procedures require any proposed language for the 2015-16 BOB Appropriations concerning the following legislative approval actions to be submitted with the initial CIP request, which is due on August 1, 2014. Final BOT approval is required by September 1, 2014:

- 1. BOB 1 Projects constructed, acquired, and financed with approved debt by university or university direct support organization.
- 2. BOB 2 Projects requiring general revenue funds to operate and maintain.
- 3. BOB 3 Change in previous appropriation.
