**PROPOSED COMMITTEE ACTION**

Request for approval of the conferral of Honorary Doctorates on Jay Salkini, Joan Rosmarin Chodorkoff, and Bernard Chodorkoff.

**BACKGROUND INFORMATION**

University Policy 2.3 (Honorary Doctorates) specifies that those nominated for Honorary Doctorates be recommended to the FAU Board of Trustees by the University Faculty Senate Honors and Awards Committee, the Provost and the President. Three candidates are being recommended:

Jay Salkini has been nominated by Mohammad Ilyas, Dean of the College of Engineering and Computer Science. A BSEE and MSCE graduate of FAU, Mr. Salkini started his own company, Tecore Networks, with a focus on wireless communication networks. His visionary approach has revolutionized the delivery of communication services and created opportunities for the next generation of wireless communication. His technical contributions have been recognized through his patents and numerous awards, including the FAU National Alumni Association Hall of Fame award.

Dr. Joan Rosmarin Chodorkoff and Dr. Bernard Chodorkoff have been nominated for Honorary Doctorates by William Miller, Dean of University Libraries. The Chodorkoffs have had distinguished careers as educators and mental health professionals, and have made important contributions to both the practice and literature of psychology, psychiatry and psychoanalysis. They have greatly enriched the cultural resources of the FAU Libraries by donating their extensive and extremely valuable contemporary cultural fine arts and crafts collection, including works by renowned artists Dale Chihuly, Ed Rossbach, William Morris and Clifford Rainey.

Dear Dr. Borko:

It gives me great pride and pleasure to recommend one of my dearest friends and business partners, and one of telecommunications' top visionary and successful leaders for the past 20 years, Jay Salkini.

After entering the telecommunications field as a young engineer, Jay decided to start his own company in 1991 with a focus on the then-forthcoming opportunities in scalable wireless communications. Through the years he has pioneered a path in wireless communications that has spanned the globe and brought communications to millions of people, while registering and introducing seven patents.

After water, food, and shelter the most immediate sought after element in life is human communication and interaction. Under Jay's leadership, Tecore brought cellular communication to the lives of people who previously had never experienced it. In many of those areas, traditional wire line devices were not available. The humanitarian contribution of enabling communications transcends the mere business success of Tecore.

Through the rise and fall of the dot com bubble and through the current challenges in the global economic environment, Tecore has not only survived, but successfully thrived under Jay's leadership. Under visionary guidance and a focus on the long term technical viability of the company and product set, Tecore has been able to outperform and outlast other competitors in the market. As previously mentioned, Tecore's work spanned the globe. Examples of these projects include, but are not limited to:

1. Libya, 2011 – After Qaddafi disabled the wireless networks in the rebel-controlled areas, families were left stranded in the most dire of war conditions without any ability to communicate with their loved ones. Facing the prospect of fighting a war without communications equipment, the Libyan rebels also required a solution to enable their

cellular network communications on the front lines. Tecore responded with an immediate and effective solution that recreated the key network elements required to return cellular communications to millions of Libyans living in those war zones.

2. Mississippi, 2010 – In response to the critical problem of illegal cell phone communications facing the correctional institutions today, Tecore pioneered the deployment of Managed Access technology in Parchman, MS. Designed to block illegal communications from inmates while still permitting prison staff to communicate, the system has blocked nearly 2 million communications to date, and stands as the reference example of how to address the illegal communications epidemic.
3. Somalia, 2006 – Tecore installed and implemented commercial communications in some of the hardest hit conflict areas of the country. Today the network continues to provide service to the people of Somalia.
4. Eritrea, 2004 – Tecore installed the first country-wide cellular network for the nation
5. Iraq, 2004 – Tecore equipment was deployed to help establish one of the first wireless networks in the country post-Saddam Hussein.
6. Guinea Bissau, 2003 – Tecore installed the first country-wide cellular network for the nation.
7. Afghanistan, 2002 – Six weeks after the Taliban-controlled capital of Kabul fell to the coalition forces, Tecore deployed a commercial GSM system in five cities across the country. This was the first wireless communications system available for the population of the war-torn country of Afghanistan.
8. Southern Sudan, 2000 – Tecore installed the first wireless network in that region, which just recently became a sovereign country.
9. Rural USA, Mid 1990's – Tecore enabled over 30% of the US operators to establish and deploy second generation (2G) networks in Rural America. From Kentucky to Texas, Kansas to Alaska, Tecore's solutions addresses a niche in the market, allowing an economical build-out solution for rural locations.

With the courage to take on challenging opportunities that make a difference, Tecore's global reach has impacted the lives of populations worldwide. From providing the first commercial network in Afghanistan in 2002 to last summer's actions assisting Libyan war-ridden families, Tecore has stood at the forefront of communications technology. The decision to pursue these opportunities with the vision and strategy to make them successful has defined Jay's career.

In his 20 years of ownership of Tecore, Jay has not only revolutionized the delivery of systems and technology in the market, but the advancements and contributions made in the industry have paved the way for the next generation of wireless communications.


Jay has been granted four patents, along with three more pending. Two of the registered patents facilitate the use of phones on airplanes, and were conceived at a time when the use of phones was unequivocally banned onboard. However, as airlines are currently searching for ways to enable the use of cellular phones, one understands the scope of Jay's vision.

Many of the key elements of the Tecore solutions incorporated years, even decades, ago as foundational in the product set are only today being adopted by the larger companies. What are today seen as common sense ideas such as off-the-shelf hardware, open operating systems and full IP-based solutions were viewed at the time by many with much skepticism and disdain.

Under Jay's leadership, Tecore continues to pioneer new markets, while expanding the reach of the company's technology. These areas of contribution are not limited to commercial communications. The systems and technologies of Tecore have assisted the government and military in their pursuit of bringing commercial, off-the-shelf wireless technologies to the bases and battlefields, as well as to disaster-stricken areas. Again, with the foresight to see the opportunity in this market, Jay's leadership kept a sharp focus internally on the adaptation of the commercial product line to address the unique needs of this market segment while maintaining the compatibility and compliance with the commercial standards. Today, Tecore solutions are used by militaries, both domestically and internationally. The communications these systems facilitate not only bringing the military modern wireless communications, they are saving lives.
