DRAFT MINUTES

WEDNESDAY, OCTOBER 19, 2011

Thomas Workman, Chair, Strategic Planning Committee, called the meeting to order and proceeded with the Roll Call of committee members.

A motion was made and seconded to approve the Minutes of June 15, 2011 without change or correction.

SP: I-1: FAU's New Strategic Plan

Dr. Kaul began her presentation by saying that she had presented a portion of the new draft Strategic Plan 2012-2017 with Signature Themes at the last Board retreat in early Fall. Since then, the Strategic Planning Steering Committee (SPSC) had made great progress and an updated plan should be completed within the next month. The four goals identified in the new Plan are:

- 1) Enriching the educational experience
- 2) Inspiring more research and creative activity
- 3) Community Engagement
- 4) Building strong financial, physical, and other structures to support the first three goals

She reported that there are a number of detailed strategies and tactics still being developed under each of the goals. The SPSC will be soliciting suggestions and ideas from students and the community and the findings will be presented for approval at the December meeting. She also informed the Board that the Committee had begun working on revising FAU's Mission Statement

Trustee Workman invited the Board to submit ideas or input to the Plan to Dr. Kaul.
