SUBJECT: SACSCOC STANDARD ON GOVERNING BOARD EVALUATION

BACKGROUND INFORMATION

Section 4 of the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) 2018 Principles of Accreditation requires governing boards to define and regularly evaluate their responsibilities and expectations as a Board. This Board's responsibilities and expectations, values, and procedures are defined in Article IX, Section 7 of the Florida Constitution; Florida Board of Governors (BOG) Regulations; applicable provisions of Florida Statutes; Florida Atlantic University Regulations; and this Board's Operations Policies and Procedures.

This Board should complete two self-evaluations – one by 2021, another by 2023 – before the University's next SACS accreditation reaffirmation in 2024. SACS provides recommendation for the evaluation process, but the details of how the Board will evaluate itself are largely left to the Board's discretion.

SACS requires that institutions within states like Florida that have more than one level of governing board must include self-evaluation data for all board levels. To facilitate SUS institutions' compliance with this requirement, the BOG conducted its first biannual self-evaluation in 2019. A survey comprised of the attached questions was completed electronically by the BOG members, and the results were tabulated, presented, and discussed by the full BOG.

To initiate this Board's self-evaluation, the administration is sharing the BOG's survey and asking Board members to consider it as a starting point for the development of this Board's survey. We will then conduct a follow-up conversation at the November meeting to finalize the survey and any other elements of the self-evaluation, with the expectation of providing it to the Trustees later in the year or early in 2021.
