**SUBJECT: APPROVAL OF EXCEPTION TO THE 120 CREDIT HOUR
REQUIREMENT FOR BACCALAUREATE PROGRAMS - CIP 50.0501**

PROPOSED BOARD ACTION

Approval of Exception to the 120-credit hour requirement for a baccalaureate program – CIP 50.0501

- Bachelor of Fine Arts in Theatre: Music Theatre

BACKGROUND INFORMATION

Changing the program requirements to allow students to participate in the Summer Repertory Theatre Program will better reflect current industry standards and departmental expectations. By modifying the credit hours from 120 to 124, the program will be able to offer experiences where students will be able to achieve higher paying jobs and employment opportunities upon graduation, as they will be eligible to join Actors' Equity, the national professional union of actors and Stage Managers in the United States. This is an exciting opportunity as no other State University Program offers an experience like this for undergraduate students. The department is revisioning the Musical Theatre degree as a tightly integrated cohort class model for students seeking training at Florida Atlantic University. The program will offer courses with a unique and innovative learning experience during the summer terms where students will work with professional performers and stage managers producing theatre. While students are completing college credits towards degree, they will concurrently earn points towards joining the union through special arrangements with URTA, the University Resident Theatre Association.

The program has been carefully crafted to maximize two summer semesters to keep students in a graduation timeline of four years at the university, supporting the university metrics and timely graduation requirements.

Effective Fall 2023, pending approval by the Florida Atlantic University Board of Trustees.







FISCAL IMPLICATIONS

Selective Programs

For reasons of accreditation standards, space, or fiscal limitations, the BFA programs in Theatre and Dance are designated selective admissions programs. Admission to FAU does not guarantee admission to a selective program. For specific information on these programs, applicants should review the Department of Theatre and Dance guidelines and review requirements above and below.

Admission Requirements

~~The departmental faculty evaluates students desiring to become B.F.A. majors with a performance concentration through auditions held each semester.~~

All students seeking admission to the BFA programs must complete a performance audition or portfolio presentation prior to the first semester of study. Students may audition for entry to the BFA program until they have earned 30 credit hours towards their degree in theatre.

Advising

All students are required to meet with an advisor each semester to ensure timely graduation. Entering students should call the department of Theatre and Dance at 561-297-3810 to arrange an advising appointment prior to the start of your term.

All students are assigned to an advisor who will meet with the student every semester to determine the student's curriculum. In addition to departmental course requirements, all BFA Performance majors must complete the following to graduate:

Degree Requirements

1. Students must meet all University and College requirements for graduation.
2. Students who change degree programs and select this major must adopt the most current catalog.
3. All courses and their prerequisite courses must be completed with a grade of "C" (2.0) or higher. Grades below a "C" (2.0) will not satisfy the major requirements or count towards theatre credits. These and other departmental policies are explained in detail in the Student Handbook, which is updated annually and available in the Department of Theatre and Dance. ~~Students must earn a "C" (2.0) in any class to be counted toward the major. Grades below a "C" (2.0) will not satisfy the major requirements or count toward total theatre credits.~~
4. Students must consult with a departmental advisor each semester before registering.

5. ~~Students must fulfil 2.0 credits' worth of production capstone prior to graduation. Students may receive 2.0 credits for stage managing a mainstage performance; 1.0 credit for stage managing a dance concert or serving as an assistant stage manager on a mainstage performance.~~ All students must complete two credit hours of Production Capstone demonstrating a proficiency in an area of theatre prior to graduation. Credit hours are earned by registering for THE 4954 and applying for a position of responsibility in the department. See the department for current production opportunities.
6. ~~All students must complete the annual evaluation successfully to continue registering in the course sequences.~~ Jury reviews are given at the end of the semester. Successful completion of the jury is required to continue enrolling in course sequences.
7. Students are required to follow all audition requirements for their degree program. ~~audition for every mainstage production and accept any casting offers.~~
8. Students may test out of MUT1111 and MVK 1111 through proficiency exam.
9. Students must enter this program in fall terms for proper course sequencing. You cannot enter this major after 30 credit hours to ensure timely graduation.

Prerequisite Coursework for Transfer Students

Students transferring to Florida Atlantic University must complete both lower-division requirements (including the requirements of the Intellectual Foundations Program) and requirements for the College and major. Lower-division requirements may be completed through the A.A. degree from any Florida public college, university or community college or through equivalent coursework at another regionally accredited institution. Before transferring and to ensure timely progress toward the baccalaureate degree, students must also complete the prerequisite courses for their major as outlined in the Transition Guides.

Please note that transfer students who have not completed A.A. degrees in Theatre and Dance will be required to complete all lower-division music requirements, which may add time to the degree.

All courses not approved by the Florida Statewide Course Numbering System that will be used to satisfy requirements will be evaluated individually on the basis of content and will require a catalog course description and a copy of the syllabus for assessment.

2. Provide a narrative on why a new exception to 120 credit hours is needed for the major(s) indicated above?

The department requests a waiver for unique and innovative learning experiences. The BFA program requires student participation in the Summer Repertory Theatre Program. This experience is a significant professional development experience where students complete a minimum of six credit hours of college credit where the laboratory training counts towards union membership weeks of work in Actor's Equity, the professional union of Actors and Stage Managers in the United States. Each course counts towards work ten to twelve weeks of work. Students are able to complete their weeks prior to graduation for entry into the union though these additional credit hours affording them higher paying jobs and employment opportunities upon graduation.


