SUBJECT: ANNUAL REVIEW OF ACADEMIC DEGREE PROGRAM LIST

BACKGROUND INFORMATION

In March 2024, the Board of Governors (BOG) amended BOG Regulation 8.011 Authorization of New Academic Degree Programs and Other Curricular Offerings. The revision disentangles new degree program planning from the annual Accountability Plan process. Universities are now able to submit annual lists of anticipated new degree programs to the BOG instead of reporting an exhaustive list of all potential new academic degree programs multiple years in advance. The new process empowers institutions to be nimbler and more responsive to quickly evolving workforce demands.

Regulation 8.011 requires each University's Board of Trustees to review its institutional submission prior to submission. The BOG notes that this is an informational item and does not require a vote.

IMPLEMENTATION PLAN/DATE

By June 28, 2024, the University will provide BOG staff with the attached list of possible or anticipated new academic degree programs.

FISCAL IMPLICATIONS

Each degree program still requires subsequent planning, vetting, and approval. Inclusion on this list does not represent an obligation by the University, financial or otherwise, to launch any of the noted new academic degree programs.

Background:



At the March 2024 meeting, the Board of Governors amended 8.011, Authorization of New Academic Degree Programs and Other Curricular Offerings, changing reporting requirements for new degree programs. The amended regulation requires universities to provide the Board office with a list of the new academic degree programs that will be considered by the university boards of trustees for the upcoming academic year. The university's board of trustees must review this list before submission. Please note this can be an information item and does not require a vote. The Board office will share the combined list for the System with CAVP and CAVP ACG to discuss program duplication and System coordination.
