# **Course Description**

We'll cover aspects of application development and what constitutes a cloud native application. Knowledge of programming and cloud foundations is required as we'll focus on building apps with focus on distributed systems, storage and networking. Once you complete this course you should have a solid foundation on what it takes to design and build an application suitable to run in a cloud environment.

Algorithms, Python, Cloud Foundations (Storage, Databases, compute options)

### **Course Objectives/Student Learning Outcomes**

At the end of this course, students should be able to:

- build a basic architecture for cloud native applications
- understand what makes an application a cloud application
- leverage different cloud products to build applications suitable for cloud deployment
- deploy application to multiple regions
- apply site reliability engineering (SRE) techniques to ensure application continuity
- understand the lifecycle of an application from inception to production
- integrate different services via APIs
- monitor traffic and spending for a deployed application

#### **Course Evaluation Method**
