Scholarship/Loan Agreement & Promissory Note

Students selected to receive the CyberCorps® Scholarship for Service (SFS) must comply with all program requirements. Receipt of this scholarship is contingent upon meeting all eligibility requirements and execution of this agreement and promissory note. *Read and carefully consider the commitments explained before signing this document.*

I. SCHOLARSHIP AGREEMENT

This Agreement imposes legally enforceable obligations on you, and is an important condition of the award to you of financial assistance under CyberCorps® Scholarship for Service (SFS).

The CyberCorps® Scholarship for Service (SFS) is a loan for service agreement. It becomes repayable to Florida Atlantic University if the recipient:

- fails to maintain an acceptable level of academic standing;
 - is dismissed from the applicable institution of higher education for disciplinary reasons;
 - withdraws from the eligible degree program before completing the program;
 - declares that he/she does not intend to fulfill the post-award employment obligation; or
 - fails to fulfill the post-award employment obligation.
- A. **Stipend and tuition:** If an undergraduate, the award includes a stipend of \$27,000 per year and 100% tuition from the Florida Atlantic University using grant funds from the National Science Foundation (NSF). If a graduate student, the award includes a stipend of \$37,000 per year and 100% tuition. The stipend will be paid in monthly increments and will continue as long as the student is enrolled in the program. In the event that a student withdraws or is dismissed from the program, the payment of these stipends will cease immediately.
- B. **Other Awards:** This award includes a professional allowance of up to \$6,000 per academic year for SFS Job Fairs and other travel, conferences, research materials, books and supplies including a one-time purchase of a laptop, professional training and certifications, etc. These will be paid as receipts are submitted to the project administrator for reimbursement.
- C. **Commitment:** CyberCorps Scholarship for Service (SFS) seeks to prepare Cybersecurity professionals for employment in the government sector (federal, state, local, tribal or territorial government organization). Upon graduation, you agree to work for the Federal Government or, subject to the approval of the NSF program office, for a State, Local, or Tribal Government (Eligible Government Institution) in a position related to Cybersecurity for a period equal to the length of your scholarship. You understand that employment with an Eligible Government Institution may require you to relocate away from your current residence. An academic year (i.e., the fall, winter, and spring quarters) is equivalent to a calendar year of employment. You agree to seek an internship and work in the government sector during the summers of your award. You also agree to provide employment data and updated contact information to program staff on an annual basis. Failure to honor these commitments will result in repayment.

- D. **Research:** In order to learn more about the design, implementation, and impact of the program, CyberCorps® Scholarship for Service (SFS) conducts ongoing evaluations. You agree to participate in these evaluations. The program will continue to collect data about your placement and retention. This data will only be used to evaluate the program as a whole. All interview and observation data are confidential.
- E. **Qualifications:** In order to qualify for CyberCorps® Scholarship for Service (SFS) the recipient must be a full-time student pursuing a bachelor's or master's degree in a coherent formal program that is focused on cybersecurity or research-based doctoral student; be a citizen or lawful permanent resident of the United States; in addition there may be instances wherein qualification for SFS requires that you meet criteria for Federal Employment; and be able to obtain a security clearance. You agree to submit to such Federal employment security screening prior to an award of SFS. Further, you understand that a loss of security clearance and/or any other qualifications as defined herein, would be grounds for termination of the SFS scholarship and instantiating the repayment provision as provided herein.

II. PROMISSORY NOTE

I agree that if I fail to meet the conditions described in Item 1 titled "Scholarship Agreement," or if I fail to satisfy the academic requirements of the degree program, I will repay the full amount of the Scholarship received to the Florida Atlantic University's Office of Student Financial Aid (OSFA).

A. Collection Charges:

1. I understand and accept that if I fail to make timely payments (i.e. delinquent payments in excess of five (5) business days) of my financial obligation to the Institution or fail to make acceptable payments to bring my account current, the Institution may refer my delinquent account to a collection agency. I further understand that I may be responsible for paying the collection agency fee, which may be based on a percentage at a maximum of 33 1/3% of my delinquent account, together with all fees and expenses, including reasonable attorney fees, necessary for the collection of my delinquent account. Finally, I understand that my delinquent account may be reported to one or more of the national credit bureaus.

B. Repayment:

1. I agree to enter repayment status on the first day of the first month after the earliest of any of the following to occur:
 - i. FAU has determined that I have ceased to be enrolled in either of the appropriate baccalaureate or master's degree programs; or
 - ii. The date I inform FAU and/or the Federal Office of Personnel Management (OPM) that I do not plan to fulfill my government employment obligation; or
 - iii. The date that FAU and/ or OPM ascertains that I have ceased to be employed in an Eligible Government Institution prior to fulfilling my employment obligation.
2. I agree to make monthly payments to FAU that covers the outstanding principal and 5% interest, and any incurred reasonable collection costs, including, but not limited to, attorney fees, according to a monthly

payment schedule established by FAU, that calls for complete repayment within seven years after I enter a repayment status (except as provided in Items IIC and IID). Interest on this loan shall accrue from the beginning of the repayment period.

Minimum monthly payments will include at least 1/60th of the total of the amount due, plus applicable interest and collection costs. If I fail to make any monthly payment as required by the schedule established by FAU, and such failure persists for a period of 180 days, FAU without further notice, may accelerate the balance of the outstanding principal due, and I promise to pay such amount plus interest and reasonable collection charges, including, but not limited to, attorney fees, to FAU.

I agree that FAU will report the amount of my monthly installments, along with the amount of this loan to at least one national credit bureau. I further agree that if I do not make the monthly payments as required by the schedule established by FAU will engage in collection efforts similar to the collection efforts used by lenders and guarantee agencies in the guaranteed student loan program, including notification of credit bureaus regarding my default and litigation.

I authorize FAU or designated agent to contact me regarding my loan, including repayment of my loan using the current or future number that I provide for my cellular phone or other wireless device using automated telephone dialing equipment or artificial or pre-recorded voice or text messages.

C. Conditions for Deferrals or Exceptions to Performance or Repayment

You may be granted an exception to the repayment requirement of this agreement in whole or in part if you are unable to continue the required course of study or perform the service obligation because of a disability that is expected to continue indefinitely, or because of death.

Deferral of your payment requirement may be granted during the time in which:

- a. You serve, not in excess of three years, on active duty as a member of the armed service of the United States;
- b. You serve as a volunteer under the Peace Corps;
- c. You serve as a volunteer under Title 1 of the Domestic Volunteer Service Act of 1973;
- d. You have a disability which prevents you from working for a period of three years.

Note that proof of an assignment to a Cybersecurity position in either (a) or (b) above, may be considered credit towards my commitment as defined in I (C).

During the time I qualify for any of the exceptions described in this Item II-C, I am not required to make Scholarship repayments described in Item II-B. In order to qualify for any of these exceptions, I must promptly notify FAU of my claim and provide supporting documentation acceptable to FAU. FAU shall extend the seven-year Scholarship repayment period described in Item II-B by a period equal to the length of time I meet any of the conditions in Item II-C.

D. Modified Repayment Schedule

If I am unable to complete Scholarship repayments within the seven-year period because of financial condition that has been established to the satisfaction of FAU, (such conditions to include but are not limited to a continuing disability, illness, or other force majeure events), FAU will establish a modified repayment schedule reflecting my

financial condition.

E. Cancellation

FAU shall cancel my repayment obligation if it determines:

1. On the basis of a sworn affidavit of a qualified physician that I am unable to work because of an impairment that is expected to continue indefinitely or results in death.
2. That I have become totally and permanently disabled as established by a sworn affidavit of a qualified physician.
3. On the basis of a death certificated or other evidence of death that is conclusive under Florida law.
4. Circumstances have occurred that FAU considers compelling reason to excuse repayment.

F. General:

1. I agree to advise FAU promptly in writing of any change in name, address, or deferment status as described in Section IIC.
2. I understand that I must complete the baccalaureate or master’s degree program.
3. I understand that I must maintain satisfactory academic progress as determined by the FAU and SFS Program Office and that Scholarship stipends will end if I do not make satisfactory progress towards a degree. Further, that ending the scholarship stipend may initiate the repayment Promissory Note as defined herein.
4. Communications on cancellation, repayment, or deferment should be made to OSFA
5. I understand that it is my responsibility to determine what if any, tax liability will accrue to me as a result of accepting financial assistance under CyberCorps® Scholarship for Service (SFS). All tax liabilities, if any, are my responsibility to discharge.

I hereby certify that: (1) I understand that the CyberCorps® Scholarship for Service (SFS) is a Repayable Scholarship, I am receiving a loan which must be repaid, in whole or in part, if I fail to satisfy the academic requirements of the program for which the funds were awarded, or fail to complete the government employment requirements of the program; (2) my rights and obligations under this loan are contained in the above terms and conditions; (3) I have read this promissory note; and (4) I have received a copy of this note.
