

INTERNATIONAL EXCHANGE STUDENTS (J-1 VISA)

The Financial Certification Form (FCF) is a required supplemental form for international applicants seeking to obtain immigration documents for international exchange student status (DS-2019). The DS- 2019 is the certificate of eligibility to obtain the J-1 visa or to request a change of status to J-1. Applicants may submit the FCF and supporting documentation at any time during their admission process. International Student Services (ISS) office will issue the appropriate immigration document only after the applicant (1) has been formally admitted to FAU and (2) completed this form and submitted acceptable financial support documents to Education Abroad: goabroad@fau.edu.

FINANCIAL INFORMATION

Original documents are preferred, but scanned/fax copies will be accepted for the initial review process. ISS may request original documents or additional information in order to verify accuracy of financial support documentation. Personal and/or family funds must be submitted on the official letterhead stationary of the bank/financial institution, and must verify that the required amount (estimated cost of attendance) specific for your situation is available for your studies. All letters must be written in English, and figures should be stated in US currency.

Note: You will be required to show original financial support documentation when applying for the F-1/J-1 visa at the U.S. Consulate.
