The meeting, virtual as well as in-person, was called to order at 10 a.m. by UUPC Chair Korey Sorge.

I. APPROVAL OF MINUTES AND ANNOUNCEMENTS

Chair Korey Sorge welcomed committee members and guests. He then asked whether everyone had read the March 25, 2024, minutes and if there were any corrections and/or additions. There being no changes, the minutes were approved.

II. NEW BUSINESS

1. University-Wide

The URCC committee proposed including the Science Fest Competition as an approved Dissemination venue for the Undergraduate Research Certificate. The competition offers undergraduates an opportunity to present their research findings in a poster session each spring. Both the abstracts and posters are evaluated by faculty judges. **The UUPC approved the proposal.**

Undergraduate Studies Dean Dan Meeroff discussed future revisions to the Simple Syllabus template that address Artificial Intelligence (AI). The FAU AI Task Force has drafted syllabus language for AI use in the classroom that is moving its way through Steering and Senate. Dean Meeroff shared that the standard language regarding AI will be added in Simple Syllabus once approved, but faculty will have space to add to that language in the syllabus. 2. Arts and Letters

Guest Chris Robé presented three items from the Communication and Multimedia Studies Department. The DIG course is having a title change to make the course's content clearer to students. **The UUPC approved this change**. The MMC course is having its prerequisites changed in response to other program changes that have already taken place. **The UUPC also approved this change**. The program change for the B.A. in Multimedia Studies was discussed next; the changes involve adding new courses and updating the core courses and other areas. **The UUPC approved the various revisions**.

AL Rep Eric Hanne described the new LAH course and then discussed the program change in the B.A. in History, where the new LAH course will be added to a list of electives. **The UUPC approved the new course and the program change.** A new minor in Music for non-music majors was then discussed. The new minor requires 12 credits. After a brief discussion, **the UUPC approved the new minor**.

3. Business

BA Rep Julia Higgs presented several items from the College of Business. MAR 2142 is having a description change and will be moving to the Social Science area of the General Education program. **The UUPC approved the changes.**

A title change and a description change to two other MAR courses were then presented, making the title more specific and adding more course details to the course description. **The UUPC approved those changes.**

BA Rep Higgs then presented two internship courses and the Advertising Concentration in Marketing that are to be terminated because there has been little interest from students. Marketing is terminating these two internship courses and keeping only the general marketing internship course available for students. Rep Higgs said the department doesn't feel there is a need for three separate internship courses. As for the Advertising Concentration, recent changes to the Marketing program's core will cause students to go over on credits if they pursue the Advertising Concentration. There being no interest in this concentration for a number of years, the department feels it is best to terminate it. **The UUPC approved the terminations.**

The Marketing Minor was discussed next. Two new courses are replacing two courses in the minor. The minor's requirement of 9 credits will not change, but this became a topic of discussion as most minors in the colleges require 12 credits. The explanation provided is that several older minors, like this one, were approved at 9 credits before the minor requirement of 12 credits was established. Chair Sorge asked if we should we make all minors under 12 credits increase their credits at the time they would like to make a change to the program? He followed this question with the comment that this could pose a problem in some programs. The Provost's Office was asked to weigh in on the matter. The response received is that it is OK to keep the few minors that are under 12 credits at their current total. **The UUPC approved the Marketing Minor's changes.**

The final item of business was a change to the Digital Marketing Minor and Certificate. The UUPC approved adding two new courses to both programs.
